DESCRIPTION

During the Pulmonary Consultation elective, students will usually be the first member of the consultative team to work up requested pulmonary consultations; they will usually be the person who presents the case to the attending staff. Students will learn to interpret pulmonary function tests with the staff. They may observe and participate in a number of procedures, such as thoracentesis or fiberoptic bronchoscopy. They will attend one outpatient clinic per week. They will participate in several didactic sessions including weekly interesting case conference or journal club.
