DESCRIPTION

During the Medicine-Pediatrics (Med-Peds) elective, students will be exposed to the unique aspects of being a Med-Peds physician and the dual role they play as both internist and pediatrician in an outpatient setting. For 4 weeks, students will work alongside our Med-Peds trained attendings to treat patients alongside a wide spectrum of age, backgrounds, and clinical presentations. In addition, students will gain the opportunity to participate in individualized mentorship sessions and self-directed learning during this personalized and tailored Medicine-Pediatrics elective based on their respective interests.

PREREQUISITES

This course is intended for 3rd and 4th -year students enrolled in the undergraduate medical education program at University of California, Irvine School of Medicine (UCISOM).

RESTRICTIONS

MS3s must obtain department approval from the course coordinator before enrolling in rotation.

COURSE DIRECTOR

Dr. Chow received her medical degree from University of Illinois – Chicago, and completed her training in internal medicine and pediatrics at the University of Michigan hospitals. She also completed a pediatrics infectious disease fellowship at the UCLA School of Medicine. Dr. Chow has practiced medicine for about 30 years and is highly involved in medical education. She currently is part of the PACE Program.

Dr. Newman received her medical degree from the Keck School of Medicine at USC and completed her training in internal medicine and pediatrics at the LAC + USC Medical Center. She has been in practice for over 15 years and is dedicated to the training of medical students and residents. She is currently a Dean's Scholar for the School of Medicine.

MAJOR ASSIGNMENTS AND EXAMS
